Interested parties may obtain the Request for Qualification Documents (the “RFQ Document”) from MPRDC from 09.01.2012 on all working days between 1030 hrs. to 1730 hrs., till the last date of submission, by written request on payment of a non-refundable fee as mentioned above by way of crossed Demand Draft drawn in favour of “MP Road Development Corporation Ltd” payable on any scheduled bank in Bhopal.

The applicant would be evaluated in terms of prescribed minimum threshold technical and financial capability criteria applicable to the bidder (sole applicant/Consortium as the case may be). Detailed information on the evaluation criteria and methodology is available in the RFQ documents.

The RFQ documents are also available on the MPRDC website (<http://www.mprdc.nic.in>). Applicant, who downloads the RFQ document from the website will be required to pay a non-refundable fee as above by Demand Draft drawn

in favour of Madhya Pradesh Road Development Corporation Ltd., payable on any scheduled bank in Bhopal at the time of the submission of the RFQ or at the time of attending the pre-bid meeting.

For obtaining document by post an additional of Rs. 500.00 (Rupees five hundred) is to be paid as postal and other related charges. MPRDC will not be responsible for any delay, loss or non-receipt of RFQ document by post/courier.

MPRDC may update, amend or supplement the information including the qualification process in RFQ document at its discretion but before the due date.

RFQ submission must be received not later than 1500 hrs. on **08.02.2012** on the manner specified in the RFQ document in the office of MP Road Development Corporation Ltd. Bhopal.
